<p>ABOUT</p> <p>PA State Capitol Building East Wing Rotunda 501 N. 3rd St., Harrisburg</p> <p><i>Drop-off will be held on Commonwealth Avenue, behind the Capitol</i></p>	<p>Artwork of all mediums and subject matter are welcome, excluding nudity or inflammatory speech. Many people pass through the Capitol Building and will have the chance to view this exhibition, so we are not dictating subject matter or theme so that you can submit your very best works! We do prefer that the artwork is for sale.</p> <p>The East Wing Rotunda can accommodate wall pieces in several size groupings: small, 8x10 to 11x14; medium, 16x20 to 20x24; large, 24x36 to 36x48.</p> <p>3D pieces may be displayed if they are able to hang on the wall. <i>Example: basket wall hanging, necklace in a shadow box, etc.</i></p>
<p>March 20</p>	<p>RSVP your interest by emailing missy@perrycountyarts.org and attaching 3 images of artwork you would like to display, with file names including title, medium and size. PCCA staff will curate a lineup of artwork and artists will be notified which pieces are accepted into the exhibition by March 30. Each artist will likely be limited to 2-3 pieces each.</p>
<p>April 10</p>	<p>PAPERWORK DUE</p> <ul style="list-style-type: none"> • Photo of yourself • Artist biography (written in third person, 150 words or less) • Artist statement (written in first person, 150 words or less) <i>If you already have an Art on Tour bio sheet, please let us know if it is OK to use, or if you have any edits/updates to make.</i> • Entry fees • List of the artwork you plan to display and sell. Please include titles, mediums and pricing and email these items to missy@perrycountyarts.org
<p>Entry Fee - \$10 per piece</p>	<p>A lot of work goes into hanging this exhibition, and it is a one-day setup, so we will need as many volunteers as we can get. The walls are high and require ladders to hang a large amount of the pieces. Artists who volunteer to help set up the show on May 1 will have their entry fees waived.</p> <p>Please indicate whether you are available for setup when you submit paperwork for the show. Climbing ladders is not required, but please let us know if you are willing to do so.</p>
<p>May 1</p>	<p>ARTWORK DELIVERY & SETUP</p> <p>Works should be delivered between 9:30 a.m. and 12 p.m. and should be clearly labeled with the artist's name, title, medium and price. If you are unable to deliver to the Capitol, please first try to make arrangements with another artist to help transport your art. If you have trouble finding help, please check in with Missy directly.</p>
