ABOUT PA State Capitol Building East Wing Rotunda 501 N. 3rd St., Harrisburg Drop-off will be held on Commonwealth Avenue, behind the Capitol	<ul> <li>Submit your best work for this special feature Art on tour exhibition in the Pennsylvania</li> <li>State Capitol Building East Wing Rotunda. Artwork of all mediums and subject matter are welcome, excluding nudity or inflammatory speech. Artwork should be at least 16x20" and should not exceed 40" in any direction.</li> <li>3D pieces may be displayed if they are able to hang on the wall.</li> <li><i>Example: basket wall hanging, necklace in a shadow box, etc.</i></li> </ul>
SEPT 5	RSVP your interest by emailing <b>programs@perrycountyarts.org</b> and attaching 3 images of artwork you would like to display, with file names including title, medium and size. PCCA staff will curate a lineup of artwork and artists will be notified which pieces are accepted into the exhibition by <b>Sept. 9</b> . Each artist will likely be limited to 1-2 pieces each.
SEPT 14	<ul> <li>ENTRY MATERIALS DUE</li> <li>Photo of yourself</li> <li>Artist biography (written in third person, 150 words or less)</li> <li>Artist statement (written in first person, 150 words or less)</li> <li>If you already have an Art on Tour bio sheet, please let us know if it is OK to use, or if you have any edits/updates to make.</li> <li>Entry fees</li> <li>List of the artwork you plan to display and sell. Please include titles, mediums, sizes and pricing and email these items to programs@perrycountyarts.org</li> </ul>
Entry Fee - \$5 per piece	<ul> <li>A lot of work goes into hanging this exhibition, and it is a one-day setup, so we will need as many volunteers as we can get. Artists who volunteer to help set up the show on November 1 will have their entry fees waived.</li> <li>Please indicate whether you are available for setup when you submit Entry Materials. Climbing ladders is not required, but please let us know if you are willing to do so.</li> </ul>
NOV 1	ARTWORK DELIVERY & SETUP Works should be delivered between 10 a.m. and 12 p.m. and should be clearly labeled with the artist's name, title, medium and price. If you are unable to deliver to the Capitol, please first try to make arrangements with another artist to help transport your art. If you have trouble finding help, please check in with PCCA staff at 717-567-7023.
