Perry County Council of the Arts (PCCA) is seeking artwork for an upcoming exhibit located at the Landis House in Newport, PA. This artwork should depict or be crafted in a style surrounding the theme of TIME. The Landis House archives include several clocks that will join the curated artwork in the ballroom of Landis House to bring together pieces of our historical collection with contemporary artwork. ## Eligible Works

Original work in any medium created in the past 5 years may be submitted. All works will be accepted for consideration. Only three entries may be made per artist. This call is open to artists regardless of race, color, religion, natural origin, gender, age, military status, sexual orientation, marital status, or physical or mental disabilities.

Artwork will be accepted from any artist willing to drop off/pick up artwork. Mailed artwork will NOT be accepted. Artwork must be physically dropped off and picked up on the agreed-upon date(s). Email the provided PCCA contact to coordinate your date/time for pick up/drop off based on the date & time guidelines above.

## Entry Materials

Artists must submit all items listed below by the entry deadline to be considered for display.

- **Entry Form**
- **Entry Fee:** Non-refundable \$15 fee covers up to 3 entries
- **Digital Image(s):** Up to 3 images per artwork, each being less than 5 MB in size. Only high-quality unenhanced jpg or png named accordingly  
*LastName\_Firstname\_Title*  
ex. *Monet\_Claude\_Water Lillies*
- **Artist Bio**
- **Entry Statement**, if desired

## Display of Work

For artwork to safely hang, all 2D artwork must be wired. Sawtooth hangers and cleats are not permitted. 2D work (excluding box canvas) must be matted and framed under glass or plexiglass. No frames that leave glass edges exposed will be accepted. Works

on box canvas with finished edges will be accepted unframed. Artwork must be on display during the duration of the event. PCCA may reject any entry that is not suitable for display.

## Sales

The entry form serves as consent to PCCA sales terms that follow. All sales are processed by PCCA. PCCA collects and remits sales tax on those sales. PCCA retains 35% of the gross sales price as commission. Artist's net check will be processed and mailed within 20 days of the end of each calendar quarter to the address provided on the entry form. Artwork that is not for sale should be marked NFS.

## Liability

PCCA will take reasonable care of artwork displayed within the exhibition. The artist will hold PCCA harmless in the event unforeseen damage occurs.
